Reminders

MyCAA Military Spouse Tuition Assistance

- > Students must notify our office of any class revisions by submitting this form as needed.
- Failure to do so may result in an overpayment and potential repayment of funds to the college and/or to the Veterans Administration.
- The VA will allow payment for **ON-CAMPUS** Math and English remedial courses (those below the 100 level) if listed as a requirement on the student's test placement scores.
- Remedial classes taken as <u>DISTANCE</u> / <u>ONLINE</u> CANNOT BE CERTIFIED unless the <u>Instruction mode</u> is "In Person" or "Hybrid".
- Courses can be certified for only one degree at a time unless an approved dual degree program is on file.
- > The Degree or Certificate Program being pursued must match the Program Intent on file with the WVC registration office prior to certification of VA education benefits.
- Independent study courses count as distance / online credits for VA purposes unless unless the <u>Instruction mode</u> is "**In Person**" or "**Hybrid**".
- Forms must be submitted no later than the <u>tuition due date</u> each quarter to ensure timely processing of VA certification enrollments.
- > Students not using CH33, CH33 TOE, or CH31 benefits are required to make payment arrangements prior to the tuition deadline.
- ➤ Qualifying students may use CH33 benefits concurrently with Tuition Assistance, please mark the Tuition Assistance box next to your CH33 benefits request if you have already registered classes with Army Ignited for Tuition Assistance.
